Course Description:

This is the Part 2 course of the Sprout Grower Training Blended Course, which is being offered as a two-session virtual instructor-led course. During the Part 2 course, instructors will review the material from the Part 1, focusing on five key modules.

The Blended Course consists of two parts: Part 1 is self-led online and Part 2 is instructor-led (either in-person or live virtual). Both parts must be completed in order to receive the SSA Sprout Grower Training Course certificate.

Prerequisite:

You must complete Part 1 of the Sprout Grower Training Blended Course. Part 1 should take 8 – 12 hours to complete. Part 1 gives you the flexibility of starting and stopping at the end of each module — it does not have to be completed in one sitting.
